# **JBS Academy Private Limited Terms and Conditions**

Welcome to the JBS Academy Private Limited's terms and condition. These terms and conditions ("Terms and Conditions"), are between JBS Academy Private Limited and you, (hereinafter referred to as "You" or "Your" or "User(s)"). By accessing our website [object Object] ("Website") and/or our app 'JBS Academy Private Limited Educate' and/or 'JBS Academy Private Limited Learners' ("Apps"), Website and Apps together shall be referred to as "JBS Academy Private Limited Platform", you agree to be bound by the provisions of these Terms and Conditions.

Please read these Terms and Conditions, along with the Privacy Policy and all other rules and policies made available or published on JBS Academy Private Limited Platform as they shall govern your use of the JBS Academy Private Limited Platform. By using or visiting the JBS Academy Private Limited Platform or any JBS Academy Private Limited software, data feeds, and service provided to you on, from, or through the JBS Academy Private Limited Platform, you signify your agreement to (1) these "Terms and Conditions", (2) JBS Academy Private Limited's Privacy Policy and any other terms that are updated from time to time. # Who May Use our Services

You may use our Services only if you can form a binding contract with JBS Academy Private Limited, and only in compliance with these Terms and all applicable laws. # Our License to You

# 4.1 Price Setting

When creating a course, you will be prompted to select a base price ("Base Price") for your course from a list of available price tiers. Alternatively, you may choose to offer your course for free. As a premium instructor, you will also be given the opportunity to participate in certain promotional programs under the terms of our Promotions Policy ("Promotional Programs").

If you do not opt to participate in any Promotional Programs, we will list your course for the Base Price or the closest local or mobile app equivalent (as detailed below).

If a student purchases a product or service in a country that requires JBS Academy Private Limited to remit national, state, or local sales or use taxes, value added taxes (VAT), or other similar transaction taxes ("Transaction Taxes"), under applicable law, we will collect and remit those Transaction Taxes to the competent tax authorities for those sales. We may increase the sale price at our discretion where we determine that such taxes may be due. For purchases through mobile applications, applicable Transaction Taxes are collected by the mobile platform (such as Apple's App Store or Google Play).

# **4.3 Promotional Programs**

JBS Academy Private Limited offers several optional marketing programs (Promotional Programs) in which you can choose to participate, as detailed in our <u>Promotions Policy</u>. These programs can help increase

your revenue potential on JBS Academy Private Limited by finding the optimal price point for your courses and promoting them through additional marketing channels.

There is no up-front cost to participate in these programs, and you can modify your participation status at any time, though changes you make will not apply to currently active campaigns.

# 5. Payments

# 5.1 Revenue Share

When a student purchases your course, we calculate the gross amount of the sale as the amount actually received by JBS Academy Private Limited from the student ("Gross Amount"). From this, we subtract any Transaction Taxes, any mobile platform fees applied to mobile application sales, a 3% administrative and handling fee (except in Japan, where we subtract a 4% fee) for any non-mobile-app sales, and any amounts paid to third parties in connection with the Promotional Programs to calculate the net amount of the sale ("Net Amount").

If you have not opted into any of JBS Academy Private Limited's optional Promotional Programs, your revenue share will be 50% of the Net Amount less any applicable deductions, such as student refunds. If we change this payment rate, we will provide you 30 days notice using prominent means, such as via email or by posting a notice through our Services.

If you opt into any of the Promotional Programs, the relevant revenue share may be different and will be as specified in the <u>Promotions Policy</u>.

JBS Academy Private Limited makes all instructor payments in U.S. dollars (USD) regardless of the currency with which the sale was made. We will assume transaction processing fees, excluding foreign currency conversion fees and wiring fees. Your revenue report will show the sales price (in local currency) and your converted revenue amount (in USD).

# **5.2 Receiving Payments**

For us to pay you in a timely manner, you must own a PayPal or Payoneer account in good standing and must keep us informed of the correct email associated with your account. You must also provide any identifying information or tax documentation (such as a W-9 or W-8) necessary for payment of amounts due, and you agree that we have the right to withhold appropriate taxes from your payments. We reserve the right to withhold payments or impose other penalties if we do not receive proper identifying information or tax documentation from you. You understand and agree that you are ultimately responsible for any taxes on your income.

Depending on the applicable revenue share model, payment will be made within 45 days of the end of the month in which (a) we receive the fee for a course or (b) the relevant course consumption occurred.

As an instructor, you are responsible for determining whether you are eligible to be paid by a U.S. company. We reserve the right not to pay out funds in the event of identified fraud, violations of intellectual property rights, or other violations of the law.

If we cannot settle funds into your payment account after the period of time set forth by your state, country, or other government authority in its unclaimed property laws, we may process the funds due to you in accordance with our legal obligations, including by submitting those funds to the appropriate government authority as required by law.

### 5.3 Refunds

You acknowledge and agree that students have the right to receive a refund, as detailed in the <u>Terms of Use</u>. Instructors will not receive any revenue from transactions for which a refund has been granted under the Terms of Use.

If a student asks for a refund after we have paid the relevant instructor payment, we reserve the right to either (1) deduct the amount of the refund from the next payment sent to the instructor or (2) where no further payments are due to the instructor or the payments are insufficient to cover the refunded amounts, require the instructor to refund any amounts refunded to students for the instructor's courses.

# 6. Trademarks

While you are a published instructor and subject to the requirements below, you may use our trademarks where we authorize you to do so.

You must:

only use the images of our trademarks that we make available to you, as detailed in any guidelines we may publish (such as our Instructor Badge Guide);

only use our trademarks in connection with the promotion and sale of your JBS Academy Private Limited courses or your participation on JBS Academy Private Limited; and

immediately comply if we request that you discontinue use.

You must not:

use our trademarks in a misleading or disparaging way;

use our trademarks in a way that implies that we endorse, sponsor, or approve of your courses or services; or

If you become subject to such a restriction while you are subject to these Instructor Terms, you will notify JBS Academy Private Limited within 24 hours, and we will have the right to terminate any further obligations to you, effective immediately and with no further liability to you (but without prejudice to your outstanding obligations to JBS Academy Private Limited). You will not use the Services to conduct or facilitate any transaction with any other individual or entity subject to such a restriction. You may not remove, export, or allow the export or re-export of the Services (or any product thereof, including technical data) outside the U.S. in violation of any restrictions, laws, or regulations of the U.S. or any other applicable country.
